Since some internet websites contain material that is inappropriate for educational use in a Club setting, we have taken the initiative to use software and hardware solutions that restrict children from getting to this material. Due to the ever changing nature of the internet, no solution is foolproof. The Boys & Girls Club of the Victor Valley specifically denies the responsibility for the accuracy or quality of information obtained through its internet account.

The Boys & Girls Club of the Victor Valley has adopted the following computer rules and ethics:

1. I will use the computer in ways that show consideration and respect.
2. I will not use technology to harm other people including the use of abusive or otherwise objectionable language in either public or private messages.
3. I will not open other people's files.
4. I will not use the computer to steal.
5. I will not use or copy software for which I have not paid.
6. I will not plagiarize other people's work (present their work as if it were my own).
7. I will not use the internet to try to obtain materials that is not appropriate for educational or recreational use. This includes, but is not limited to, sexually explicit material, explosive materials, hate speech materials, and hacker sites.
8. I will not give out personal information such as my address, telephone number; parents work information or the name of the name of my school or club.
9. I will tell a staff member or parent right away if I come across any information that makes me feel uncomfortable.
10. I will never agree to get together with someone I "meet" online without online without first checking with my parents.
11. I will not enter chat rooms other than those approved by the Club or download or use any type of instant messenger service.
12. I will not download any other type of software without permission of a staff member.
